About the Pottawattamie Conservation Endowment Fund

The Pottawattamie Conservation Foundation was established in 1993 to support conservation of natural resources through public education and provide funding for preservation of land for habitat and public enjoyment. This endowment fund supplements existing resources to ensure continuation of natural areas management, environmental education programs and recreational opportunities in Pottawattamie County, Iowa.

The Pottawattamie County Conservation park system includes Arrowhead Park in Neola, Botna Bend Park in Hancock, Farm Creek Public Wildlife Area in Carson, Hitchcock Nature Center in Honey Creek, Narrows River Park in Council Bluffs, Old Town Park in Macedonia, and Wheeler Grove Conservation Area in Carson.

The Endow Iowa tax credit program allows donors who start or give to an Endow Iowa qualified fund, such as the Pottawattamie Conservation Endowment Fund, to be eligible to receive a 25% Iowa tax credit, in addition to a federal charitable income tax deduction. As an extra bonus, the Pottawattamie County Community Foundation will add a 10% contribution to the Pottawattamie Conservation Endowment Fund. All donations to the Pottawattamie County Community Foundation are fully tax deductible, as allowed by law.
